Subject: **Dismissal of Application for Certification of Class Action Against the Company and Others**

Further to the report dated March 18, 2021 (reference: 2021-01-039096), and as described in note 18.B.1.d to the company's financial statements for December 31, 2023, the Company hereby report that on October 9, 2024, the District Court of Tel-Aviv dismissed an application for certification of class action filed against the Company, ICL Group Ltd ("ICL") and against the Company's controlling shareholder, which was filed on March 2021, concerning allegations regarding alleged violations of the Company's reporting obligations related to the implications of the 2011 royalties arbitration (the "**Application**").

In its ruling, the honorable court rejected, among other things, the applicant's claims regarding misrepresentation in the Company's reports, determined that no damage has been caused, and that claims pursuant to the Application are dismissed under the statute of limitations. The court further determined that the applicant shall bear part of the Respondents' expenses, as it was found that, after hearing the Application, it had no grounds and consisted of multiple challenges.
